**Tuition Policy and Payment-** Tuition is based on a 10 month season starting in September and going through June. A professional teaching staff is contracted for the same term, and for this reason, credit will not be given for dropped or missed classes. *This is not a monthly dance program.* **I understand it is my responsibility to attend all classes and pay tuition as posted on the tuition agreement form attached.** In cases of medical emergency, credit may be given upon receipt of a doctor's certificate and written notification. **Tuition Rates are posted on the Tuition Agreement Form (see reverse side)**

- **Payments received after the due date will be charged a \$15.00 late fee.**
- All returned checks will be charged a \$35.00 fee.

**Registration Fees**

There is a \$25.00 per family registration fee that is due with your first tuition payment. This fee is non refundable.

**Recital/Performance**

MCDA participates in a full scale professional performance every other dance season. This is a recital year. Our **tentative** rehearsal and performance dates are **June 11-16, 2012**. Attendance is mandatory if you sign up to participate. Participation is voluntary.

**A 50% costume deposit will be due by October 15, 2011 and the balance will be due February 18, 2012.**

Costumes fees are as follows: Preschool & Kinder Combo -	\$60.00
Elementary Beginner Levels-	\$70.00
Other Levels and Classes -	\$80.00.

All dancers will need to have the appropriate dress code shoes. Good class attendance is expected from all students. Students who miss too many classes and/or choreography may not be allowed to perform. **No refunds will be given for costumes for any reason.** All costume sales are final.
